Prince George's County Click 311

Have you ever wondered who to contact when you needed to have bulky trash removed from your property? Or, who to contact when your trash was not picked up, or that ginormous pothole ate your car? Well, County Click 311 is your one-stop shopping portal for all of the above and more. This website is a cornucopia of Prince George's Countyrelated information. County news, events, meetings, and announcements are easily accessible and always current. The website also has a "Request a County Service" page where you can request/report anything from deceased animal removal, to street light outages, to vandalism. If you are into this type of thing, you can even request Waste Management Facilities tours! One of the areas that property owners have found extremely useful are the Code Enforcement pages. On these pages you can file a service request/complaint for property violations of the County Code (which you can also find on the website). Filing is pretty straight forward. You select the service type, i.e. Code Enforcement-Single Family Home, insert the address, add service information (single or multifamily unit), add the issue with the property (car parked in the yard, uncut lawn, trash in yard, etc.), add your contact information, provide any comments and/or pictures, then review and submit. Once submitted you will be given a Service Request Number that will allow you to track status. Within 30 days of the request initiation, a County Inspector

will investigate the property in question and if a violation is verified, issue the offending property occupant or owner a violation notice or citation. The notice/citation will give the owner/occupant a certain amount of time to correct the violation. If the owner/occupant does not correct the violation within the allotted time, the County may request a court order that directs the owner/occupant to correct the violation.

The County has a detailed list of what it considers property violations, some of which include:

- Exterior properties should be maintained in a clean, safe, and sanitary manner.
- Exterior properties should be free from weeds and grass in excess of 12 inches.
- Open storage of any household appliance, motor vehicle parts, building materials, furniture, dead trees, garbage, or similar items are prohibited.
- Not more than one motor vehicle that is wrecked, dismantled, inoperable or unlicensed is allowed on a property; and, the one vehicle that is allowed must be inside a closed garage.
- Piles of broken branches stacked on your lawn.

Oh Deer!

I have resided in Captains Cove for 25 years and have noticed an increase in deer issues as they relate to vehicle damage, personal safety, personal property and common area damage. The white-tailed deer population in our area is becoming more and more of a problem and nuisance. I must say they are beautiful creatures. However, white-tailed deer have become overly abundant in our neighborhood as well as Prince George's County hence, a need for non-lethal deer management techniques to be implemented. Non-lethal methods do not reduce or control deer population numbers, but can reduce deer damage to property, the risk of contracting Lyme disease, and forest degradation. Non-lethal methods include the use of taste and/or odor-based repellents, deer-resistant plants, scare techniques such as auditory or visual deterrents, fencing, and eliminating abnormal food sources (humans feeding the herds). Over the years I have tried many types of repellents to no avail but recently found a product called "Bobbex Deer Repellent" that has worked for me quite effectively.

A major point in deer management is to report incidents to county and/or state authorities. They maintain statistical data that supports the need for additional deer management techniques to be implemented. Deer-related incidents can be reported to:

A) Maryland National Park and Planning Commission has deer management jurisdiction over the county parks. (contact number is 301-627-7755)

- B) Maryland Department of Natural Resources has jurisdiction over all other areas within the county. (contact George Timko, 301-855-1748 or 301-478-2314)
- C) Contact the FWECA Beautification Committee Chair (Lawrence Thrash, 240-463-5318)

Both Maryland offices work in conjunction with the county animal control division.

Fort Washington Trivia

During the War of 1812, 4,000 veteran Redcoats landed on the Patuxent River, marched in a wide arc around Fort Washington—the only defensive fortification in the area until the Civil War—and burned the Capitol.

Three days later a squadron of 10 Royal Navy warships approached Fort Washington and began shelling it. The fort's commander, Captain Dyson, retreated with his small garrison of men and blew up the magazine, destroying the fort. Dyson received a court martial for his actions. After the war. Fort Washington was quickly rebuilt at the request of President Monroe.
